SAMPLING AND HYDROLOGICAL MEASUREMENT

On commercial terms FSBI KamchatTechMorDirectsiya performs regular observation of hydrological characteristics of water bodies, as well as sampling of sewage discharge and natural water, sampling of bottom sediments, soils and grounds, ice, snow coverage and hydrobionts.

To fulfil the works, The Institution employs boats, based in the sea ports of Petropavlovsk-Kamchatsky, Magadan and Anadyr.



DOCUMENTATION DEVELOPMENT

On contractual terms the Institution fulfils the following types of paid works:

- development of plans for prevention and elimination of emergency oil or oil products spills (Oil Spill Response Plans);
- development and support of Training Plans and Programs for emergency oil spills;
- works on assessment of the environmental impact;
- preparation of materials for the state environmental audit;
- development of project environmental documentation for hazardous waste management;
- development of draft standards for maximum permissible emissions;
- development of draft standards for permissible discharge levels;
- development of environmental action plans;
- other kinds of environmental documentation.

VALID LICENSES

The Institution has the license No. P/2016/3082/100/П dated July 28, 2016 for undertaking the activities in hydrometeorology and related areas, including:

- hydrological and oceanological characterization of the environment;
- determination of the contamination level of atmospheric air, soils, water bodies concerning sampling;
- preparation of and providing customers with analytical and estimated hydrological and oceanological information and information on contamination level of atmospheric air, soils, water bodies.



The Institution has at its disposal:

- specialized vehicles for different purposes, hydrological equipment, sample probes for sampling of seawater, sewage discharge and bottom soils, as well as refrigeration systems for transporting the samples;
- staff of specialists performing comprehensive studies of marine areas;
- possibility of involving specialists from scientific research institutions.

For planning of major environmental activities the specialized logistics is carried out in accordance with the location of the customer's objects.

EXPERIENCE AND QUALITY ASSURANCE

Since 2006 the Institution has been developing environmental documentation for organizations in all forms of ownership, including plans for prevention and elimination of emergency oil spills for Administration of Petropavlovsk-Kamchatsky sea trade port, enterprises and organizations maintaining the hazardous facilities of federal and local levels, as well as oil transporting vessels in the Far East sea ports.

The developed documentation was considered and approved by 16 regional government bodies in 4 units of the Russian Federation (Sakhalyn Region, Primorsky, Kamchatka and Khabarovsk Territories), by the Far East Division of the Russian Emergency Situations Ministry, by the Russian Federal Agency of Marine and River Transport, by the Russian Federal Fisheries Agency, by the Federal Environmental, Engineering and Nuclear Supervision Agency, by the Ministry of Agriculture of the Russian Federation, by the Ministry of Ecology and Natural Resources of the Russian Federation and received final approval by the Administration of Federal Territory Support of the Russian Emergency Situations Ministry, Moscow.
